What is Workplace Giving?

Workplace Giving is a simple and tax-effective way for employees to donate to charities through a regular payroll deduction. You can choose to donate as much or as little as you like.

Tackling cancer takes all of us. You and your employer can make a real difference in achieving the vision of a cancer free future.

How it works

Your donation will be made from your pre-tax earnings. This will reduce your taxable income and contribute to making a real difference to West Australians affected by cancer.

The total amount of your donations is included in your annual PAYG summary, so you don't need to collect, keep or claim any receipts - it couldn't be easier!
